2 部長陣石油氣小巴改裝工程招標說明文件

1. 招標項目 (投標項目編號：YOT/MS/2018-001)

改裝 2 部長陣石油氣小巴為流動中醫醫療車，提供內科診症及配藥服務。

2. 車輛改裝規格及詳細內容要求

投標者提供之改裝車輛規格，必須符合本堂詳列於附件 2 (見第 4 頁至第 7 頁)的內容。附件 3 (見第 8 頁)之車輛改裝草圖只作參考用途。

3. 交貨日期 (包括所有改裝工程及通過政府有關部門審批)

本堂與中標承辦商簽妥之「訂購單」內列明為準，一般不超過 3 個月內。如本堂急需有關工程，中標承辦商須根據本堂提供的指定日期完成各個項目。

4. 改裝工程保養期

每部改裝車輛之保養期為交貨後 36 個月或行車 10 萬公里，以先到期者為限。其中附加安裝之冷氣機、發電機、輪椅升降台、車輛穩定裝置、及其他改裝配件等之保養期為驗收後 24 個月或按原廠保養為限。

5. 遴選準則及程序

按本堂投標程序執行是項投標事宜。本堂不一定採納索價最低的投標書或任何一份投標書，並有權與任何投標承辦商商議批出合約的條款。本堂保留最終之審批權利，承辦商不得異議。

6. 正式通知
